To account for processing error considerations during preparation, it is suggested to measure an additional **10%** of the required quantities of ingredients.

Suggested Method of Preparation

- 1. Calculate the required quantity of each ingredient for the total amount to be prepared.
- 2. Accurately weigh and/or measure each ingredient. Consider batch size and density conversions if required.
- 3. In an appropriate size beaker, melt Techna 20[™] SF base in a hot water bath at 42-46°C, stirring frequently. Keep melted base on the hot water bath. Do not overheat
- 4. Using a mortar and pestle, triturate Pimobendan to a fine powder.
- 5. Slowly add Pimobendan powder to melted base to prevent clumping and ensure mixture is uniform before adding additional powder.
- 6. Add flavor and mix well.
- 7. Allow mixture to cool to between 40-45°C before pouring.
- 8. Pour Step 7 into mold, quickly filling each cavity. Average cavity volume is 1.5 ml
- 9. Allow to cool at room temperature.
- 10. Final preparation should be a molded troche.
- 11. Transfer the final preparation into an appropriate dispensing container.
- 12. Suggested Quality assessments
 - a. Appearance and feel
 - b. Quantity
 - c. Label auxiliary labels, storage, BUD, compounded medication

Average weight for gummy when using Techna 20[™] SF base with silicone bone mold is 1.635 g

Packaging: Tight, light-resistant container.

Estimated Beyond Use Date: 180 days per USP 795*

Labeling: Keep out of reach of children. Use only as directed. Protect from moisture and light.

Stability: Anhydrous formulation.

Note: Potency Range Recommendation: ≥90% and ≤110% of the theoretically calculated active(s).
