<b>Ingredients</b>	Proprietary formula that contains specific dimethicones, cyclomethicone, ethoxy diglycol.** **Compounding APIs into VersaPenn™ AG that are highly susceptible to oxidation, it is recommended to incorporate an antioxidant into the final formulation.
